Memorandum of Agreement 2021-2022

Students must adhere to the following MANDATORY REQUIREMENTS. Full and complete participation in the P2S Program is required to earn the scholarship and Laptop at the end of the school year.

MENTORING - You are expected to meet with your mentor for at least 1 hour on a regular weekly basis as a requirement to earn a laptop. The mentor must sign off on the weekly meeting log

_____ I understand that I will be required to meet 1-hour weekly with my mentor to earn a laptop computer for furthering my education.

CLASSES - You are expected to attend all the workshops/classes. P2S will provide one-two workshops a month on a range of topics that P2S feels is important to your development. You will receive \$200 towards a scholarship for every class attended. If you miss more than two classes, you will be subject to dismissal from the program.

_____ I understand that I will be required to attend each monthly class and will earn \$200 per class (10 classes x \$200 per class = \$2000) in scholarship money for furthering my education.

JOB SHADOWING – You are expected to complete a minimum of two job shadowing opportunities before September 2021 as a requirement of earning a laptop for continued education.

_____ I understand that I am required to complete 2 job shadowing sessions

SCHOOL VISITS – You are expected to complete school requirements for P2S staff and mentors to meet with you at your school. Each school has different requirements, and it is your responsibility to complete the necessary forms.

_____ I understand that I am responsible for completing necessary forms so my mentor can visit my school

CONTINUED EDUCATION – If, for any reason you are no longer enrolled in school, do not complete your senior year, or decide not to pursue post high school education, this agreement will be void. Scholarship money is available for those who complete the program and must be used within two years after completion of the program.

_____ I understand that I am committing to the program for one year

CONDUCT – It is expected that you will always conduct yourself with decorum and dignity. You represent your own brand as well as that of Pathway 2 Success. This includes at school, in the community and on social media. Conduct and social media postings which reflect poorly on you or P2S may be grounds for dismissal from the program.

_____ I understand that responsible for good conduct in my community and on social platforms

COMMUNICATION – If you are unable to attend a meeting with your mentor or unable to attend a class you need to let the mentor /AUM Staff know in advance. You are responsible for responding in a timely manner to communication from your mentor or the program staff. All emails and texts must be

answered within 24 hours. If you are unable to uphold the mandatory requirements, you need to clearly communicate that to AUM staff in advance.

_____ I understand that I am expected to communicate regularly and openly with program staff and mentor

Etiquette - Be respectful to AUM Foundation staff, mentors, and guests. Proper etiquette is expected when it comes to all things and especially the following:

- **Group Me App**- Keep alerts on and check regularly as we use this platform to communicate with you
- **Mentor Communication** – meet with them **WEEKLY**. Respect commitments agreed on. Do not assume your mentor wants to pay for everything if going on an outing together.
- **Late Arrival** – arriving late is disrespectful so be on time. Especially to classes. (you will not get the \$200 credit towards your scholarship if you are more than 20 min late)
- **Email** – Thoroughly read entire email before responding. Address each ask. Use proper English and grammar.
- **Title** – Address mentors and staff according to their preference. Use professional titles for formal documents, formal letters, or posting on social media.
- **Cell Phones** – silence cell phones in class and while with your mentor.
